

Appendix A- Clerks Report- November

- Confirmation that The Flood and Water Department is the Flood Risk Department with LCC. This is where Highways passed on our request for a meeting to. Representatives of both Flood Risk Department and Highways will be present- Date to be scheduled for the end of November
- Additional Street Lighting- Stow Road- - WLDC- Cllr Mullally has put a request into WLDC for footpath lighting or we could purchase street lighting ourselves £15,000 minimum for 10 additional columns
- Update from highways regarding standing water outside of Bradshaw – No additional work scheduled.

Fix my Street

- Concrete posts reported as being dumped by a resident have been re-reported. Cllr S Christie informed the clerk that these have not been removed.
- Hedges - The Close- reported- status investigating
- Streetlight obscured by overgrown trees Fleets Road- reported
- Reported bush on Eastfield has been maintained
- Maintenance has taken place to resolve standing water on Saxilby Road- Status- FIXED
- Resident querying ownership of a hedge which borders the Footpath from Kisgate to The Close and his property. Clerk has liaised with LCC for clarification on who is liable for maintenance. LCC has confirmed that the resident is liable for the maintenance of the hedge.
- Query from resident regarding a pipe leak on the verge outside of their property on Tillbridge Road- Support from Cllr Wimhurst was sought. Unsure if the issue has been resolved.
- Enquiry ongoing regarding trees opposite resident property at Capps Island, adjacent the field currently housing horses, towards Stow. Original concern that these are dead/dying and may crash into their fence/property. LCC have investigated. After further investigations, I can confirm that the area around the property is the responsibility of Highways, including the trees and the dyke and apologies for the earlier oversight
- Shaping and pruning of the Parish Council trees on the open at Old Rectory has taken place this afternoon

- High Visibility 30mph for Tillbridge Road CSW signs have been purchased- Waiting for delivery.
- LRF training exercise - New Officer Kimberly has been in touch, training to be organised.
- The Internal Auditor has made contact- Checklist to fill out prior to audit has been completed and returned. Booked 17th November
- Planning comments submitted from the extraordinary meeting

- The wet pour maintenance for the village hall playpark will be scheduled for a dry day.

- Stow village signs were created by a company Sharps of Stow- rough costings £4500 + vat. This was (2022) costings for 4 signs.
- The ditch near The Glebe/Old Rectory Gardens has been cleared- deducted amount than originally quoted
- Letter sent to Bransby regarding hedge maintenance, response received £200 donation for the work
- Tillbridge Solar Development has been passed
- One grass tender has been received
- The road sweeper has visited the village
- A resident has volunteered to litter pick outside of the litter pickers remit e.g. beyond the 30mph limits, footpaths etc.
- Parking concerns at The Glebe has been raised by a resident. Multiple cars seem to be permanently parking within the turning point with one car looking to be sheeted over for winter. The road sweeper was unable to access the area and there is a concern for access for emergency vehicles.
