## Community Speed Watch

As we move from winter into spring the Community Speed Watch group are continuing to run Speed Watch sessions on all four roads in to (and out of) Sturton and also on Cowdale in Bransby. We are now able to do sessions earlier and later than during the winter so you might see our signage and see us in our hi-viz jackets at any time during daylight hours.



Any vehicles recorded at 35 mph or above will be reported to the **Lincolnshire Road Safety Partnership** and the registered owner can expect to receive a letter from the LRSP. Speed Watch is not about enforcement however – it is about education – and we hope that by continuing to run these sessions we can encourage drivers to slow down as they go through our villages.

During 2025 we ran **41 one-hour sessions** and detected 509 vehicles travelling at 35 mph or above (approximately 4.4%). Unfortunately we had to cancel a further 17 sessions due to bad weather or lack of volunteers so we could always do with more people!

Currently there are 12 of us in the group but if we had a few more people we could put on more sessions and the spread the load a bit. Countrywide there was heavy and prolonged snowfall, lasting 55 consecutive days, and between snow showers it became bitterly cold, -21o C was recorded, causing the river Thames to freeze. Frozen snow, in places was up to a metre deep, with 7 metre snowdrifts. Transport systems experienced chaos, energy supplies were paralyzed leading to rationing, factories closed, hardship required military aid and international help to distribute food and fuel. A rapid thaw in March brought about widespread flooding, particularly along the Thames basin.

## Grant funding scheme for Property Flood Resilience

Earlier this year, Lincolnshire County Council launched a new **Property Flood Resilience (PFR)** grant scheme, offering **up to £5,000** to help homeowners protect their homes from future flooding. Key Details:

- **Invitation Only:** Eligible properties that previously suffered internal flooding have been contacted in Phases 1 & 2. Phase 3 will include homes affected between October 2023 and January 2024 (including Storms Babet & Henk). Properties that claimed under the Defra scheme are not eligible.
- **First-Come, First-Served:** Apply promptly once invited.
- **Funding:** Up to £2,500 upfront following approval, if the costs exceed this amount the remaining balance (up to an additional £2,500) will be paid upon completion.
- **No Mandatory Survey:** A professional flood risk assessment is recommended but not required.

If your home flooded and you haven't received an invitation, email [PropertyFloodResilience@lincolnshire.gov.uk](mailto:PropertyFloodResilience@lincolnshire.gov.uk) to confirm eligibility and request an application form.

## Flooding and Drainage Meeting – Public Summary

Representatives from **Sturton by Stow and Stow Parish Councils** met with Lincolnshire County Council (Highways and Flood & Water teams) and the County Councillor on 3<sup>rd</sup> December 2025 to discuss recent flooding in the villages and how future risks can be reduced.

The meeting focused on how local drainage coped during recent extreme weather, including the January 2025 floods, and what actions different organisations can and cannot take.

### Key Points from the meeting

- Flooding in the village is caused by multiple factors; extreme rainfall, saturated ground, limited capacity in drainage systems, blocked/damaged pipes, and watercourses that are not being maintained.
- Highways are responsible for draining roads, not private land.
- Anglian Water manages surface water and sewerage systems.
- Landowners are responsible for maintaining watercourses (ditches, drains, streams) next to or running through their land – known as riparian responsibility.
- Drainage systems are not designed for extreme weather events, and adding more gullies alone will not solve the problem.
- Flooding and more intensive downpours are becoming more frequent due to climate change and managing risk will require a shared approach between agencies, landowners, and residents.

### What Is Being Done

- LCC confirmed that highway drainage is being maintained and monitored.

- Damaged pipework from historic utility works has already been replaced in some areas.
- LCC Flood & Water and Highways teams work closely with Anglian Water, Internal Drainage Boards and the Environment Agency.
- A public multi-agency meeting is supported, where residents can hear directly from the organisations involved.
- LCC has provided an article explaining how Fix My Street reports help prioritise works.

### What Residents Can Do

- Report flooding, blocked drains and gullies using Fix My Street – multiple reports and photos help prioritise action.
- Check whether you have riparian responsibility for nearby ditches or drains and ensure they are maintained. The general rule is, if the deeds do not state that you are not responsible then by default you are under common law. Those who are tenants of housing or lease holders of land, it is recommended that you clarify with your home/landowner who is responsible for carrying out riparian responsibilities.
- Consider property-level flood protection, such as flood gates or air-brick covers.
- Check eligibility if your property suffered from internal flooding from Storm Babet or Henk for available funding (see above).
- Be mindful that increasing hard surfaces (e.g. block-paved driveways) can worsen flooding.
- Use the village Community Emergency Plan, including sand bins and local support, during severe weather.

### A message from LCC Highways

All 'Fix my street reports' submitted by members of the public, will be transferred into a Confirm enquiry which provides valuable data and audit-able information, as well as providing safeguards for timescales replies and updates to the sender.

- Using Confirm provides us with a centralised knowledge base of real-time insights into how assets behave and affect each other, helping us to make proactive, informed decisions for the long-term benefit of our service delivery model.
- It allows our management team to see our demand from differing work streams and is also used in calculating our resourcing picture required in weather events or intense periods of demand.
- The data captured will be used, as part of a wider scoring criteria, to inform our future plans for investments for projects such as resurfacing, drainage upgrades and replacements as well as many other things.

The Parish Councils will continue working with LCC and partner agencies to seek practical solutions and keep residents informed.




Dear Residents of **Sturton by Stow** and **Bransby**,

2025 has been an especially busy and challenging year for your volunteer Parish Council, starting as it did with relentless rain and severe flooding, which sadly made its' way into several properties. We are still facing the aftermath, with some residents only now (1st. December 2025) getting to the point of being restored into their homes, and us pressing for effective action from the various authorities concerned. Our open public meeting with Anglian Water does seem to have driven several areas of improvement, and Council meetings with Highways and the Flood Prevention Forum are expected to give us further successes in reducing the impact on the village, and those who travel through it. Your Councillors have engaged in walkabouts of our whole parish, identifying any areas of concern; the Council has also installed more sandbag bins, so that in any future times of crisis, residents have the materials available to protect their homes. Any residents or landowners with ditches, dykes and culverts next to their properties are reminded of their riparian responsibilities to keep them clear, thus enabling surface water to find a way out of the village. Our meetings are very often complicated by the attention which needs to be given to planning applications, and any residents thinking of new buildings or alterations are implored to think of the land drainage implications, as well as the "look" of Sturton.

The Council has been saddened by the resignation of Cllr. Dennis Taylor, who has served us for so long- his massive historical and detailed knowledge of the local area and people has been of immense value to us. We wish him a happy "retirement", since stalwarts such as Dennis never really retire! We were fortunate to welcome Anthony Capuano, a retired GP, onto the Council, who has brought fresh energy into our efforts to serve our community. We still need more volunteers to bring us up to full strength!

The West Lindsey precept which funds our works in the village is informed by a budget drawn up by the Council, and we have worked hard to keep our cost increases down for the coming year to no more than inflation. We continuously look for value



for money in all of the contracts that we place on your behalf (grass cutting, tree management, playpark maintenance etc.), even reducing costs with two-year contracts where possible. This then enables us to better fund the village groups which apply to us for support grants. You may not be aware that the litter-picking and small maintenance jobs quietly carried out throughout the year are performed by part-time employees of the Parish Council- our thanks to them as always.

I would urge all residents to help us where you can, by using the FixMyStreet app to report infrastructure issues around the village. This makes authorities such as Anglian Water,

Highways, and West Lindsey aware; the more reports there are, the greater likelihood there is of early attention. This also applies to the sad occasions of antisocial behaviour we sometimes see. The more times this is reported to the police, the more chance there will be of something being done by their stretched resources.

The village Speedwatch group does so much to try and prevent vehicles speeding through our village, sterling volunteer work! Do offer your services to help them if you can.

Stacey Hoyland is our hard-working Parish Clerk, and our only full-time employee; especial thanks for her hard work on keeping on top of the detail in everything, particularly in the keeping of our financial records- governed by ever-increasing regulation!

We are working on a new development to encourage residents and visitors alike to use the footpaths in the countryside around the village, with leaflets and signposts to make them more of a feature. The launch of the scheme is aimed at next Spring.
